This petition, circulated by **do.town**, is in support of the City Council considering an Edina community garden at Yorktown Park between York Ave South and 7300 Block in Edina.

The petition was circulated at the Durham apartment complex, 7201 York Avenue South Edina, adjacent to the proposed site. There are 264 units at the complex with residents from a variety of cultural backgrounds.

The signatures collected demonstrate positive support for a public community garden that is accessible to Edina residents who live in apartments and are interested in growing culturally specific foods.

This petition also reinforces letters sent to the City Council early this month supporting a community garden resolution that includes both public and private land in the city.


