**Action Requested:**

Adopt attached Resolution No. 2014-36 designating No Parking restrictions on Hazelton Road from France Avenue to York Avenue.

**Information / Background:**

This resolution is for the Hazelton Road Improvements Project. Hazelton Road is designated as a Municipal State Aid (MSA) roadway. This project is designed to MSA standards but is funded with local funds. The improvements do not provide adequate width for parking on both sides of the street thus requiring a no parking resolution. Parking is currently not allowed along the corridor. There is not an existing no parking resolution for this roadway.

**WHEREAS**, the City of Edina has planned improvements for Hazelton Road from France Avenue to 900' East of France Avenue, State Aid Project No. 120-166-004; and

**WHEREAS**, the City of Edina will be expending Local Funds on the improvements on Hazelton Road; and

**WHEREAS**, this improvement does not provide adequate width for parking on both sides of the street; approval of the proposed construction as a Municipal State Aid street project must therefore be conditioned upon certain restrictions;

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Edina, Minnesota, that the City Council of the City of Edina hereby bans the parking of motor vehicles on Hazelton Road, from France Avenue to York Avenue:
