Information / Background:

Pie Wild, Inc. dba PizzaRev applied for new wine and beer liquor licenses for their new restaurant located at 7529 France Avenue. They have filed the necessary paperwork and paid the applicable fees for the licenses.

On 07/03/14, The Edina Police Department completed an investigation relating to City of Edina application for an On-Sale Wine and 3.2 Percent Malt Liquor license. The application was submitted by Pie Wild, Inc. dba: PizzaRev. PizzaRev is a new business to Edina and will operate at 7529 France Ave, Edina, MN 55435.

Pie Wild, Inc. was duly formed in the State of Minnesota, and is registered with the Minnesota Secretary of State. Pie Wild, Inc. is active and in good standing in Minnesota.

I spoke with Katherine Becker, Becker Law Firm P.A. Ms. Becker represents Pie Wild, Inc. in connection to the City of Edina's liquor licensing process. Ms. Becker stated Pie Wild, Inc. is aware of the City's requirements with regards to alcohol awareness training for employees. Ms. Becker indicated Pie Wild, Inc. will provide an approved program for PizzaRev staff in accordance with Edina City Code.
