

# WELCOME TO A MEETING OF THE EDINA CITY COUNCIL



## PUBLIC PARTICIPATION GUIDE

Council Members welcome public engagement in a variety of ways: over the phone, in writing and in person through conversations at meetings and public events, among others. In addition, there is an opportunity for the public to provide formal comment at regular City Council meetings.

**Community Comment** is a time on the agenda for the public to raise an issue or make a comment about something not on the agenda, planned for a future public hearing or for which a public hearing was held in the preceding 30 days. The Mayor may limit the number of speakers. No action will be taken on community comment at that meeting.

Each speaker is typically allowed three minutes to speak. Before beginning your remarks, state your full name.

The City Manager will respond to comments at the next regularly scheduled City Council meeting.

**Public hearings** allow the public to provide feedback on specific topics. The Mayor will ask for public testimony after City staff and project applicants have made their presentations.

City Council work sessions do not include time for Community Comment or public hearings.
